DATA PROTECTION PRIVACY POLICY MANCHESTER AND SALFORD FILMSOCIETY

The purpose of this Policy is to give you a clear explanation about how we use the information we collect from you and to introduce a policy complying with the General Data Protection Regulations (GDPR) 2018 and subsequent amendments.

Who we are

The Film Society was founded in 1930 as a not-for- profit organisation run entirely by volunteers. Members of the Society must be aged 18 years or over. People aged under 18 will be admitted, on payment of the predetermined charge, only if accompanied by a responsible adult, either member or guest, to age-appropriate films in accordance with the categorisation of the British Board of Film Classification.

We do not collect any information about anyone under 18 years of age.

We are concerned to protect your privacy. We do not sell, rent or trade your personal details and email information with other organisations or companies for marketing purposes.

We have introduced this Privacy Policy to comply with the GDPR rules introduced on 25th May 2018 and as amended.

What information do we collect about you?

We collect information about you when you interact with us, make an enquiry, become a member of the Society, buy a guest ticket or register for an event, attend an event, sign up to our mailing list, provide feedback or complete a survey. Your interaction with us can be by email, telephone, post or in person. We collect information that is necessary to enable us to carry out the running of the Society, comply with our contractual obligations to you and keep you informed of our activities.

The type of information we collect consists of forename(s), surname, email address, telephone contact number(s) and postal address.

We do not use cookies when you visit our website.

We will keep your personal data only as long as it is necessary and useful and where we have a legitimate interest in processing the data or you have given your consent.

How will we use the information about you?

We collect information to enable us to run the Society and its events efficiently, fulfil our contractual obligations to you, provide you with the services you have requested and keep you informed. We collect information about you to process your membership, ticket-bookings or orders, manage your account, and send you emails or MailChimps with news, events, opportunities and information if you have signed up to our mailing list.

Will anyone else have access to my information?

We will not disclose your personal information outside the Society except to help prevent fraud, or if required to do so by law.

However, we do on occasions use another website and its services. MailChimp is used to keep you up to date with our programme and events and to circulate information on various matters, such as feedback. For this purpose, we use a mailing list which is part of the MailChimp application.

Where is your information?

We are committed to protecting your personal information. Data, including non-digital information, is securely held by designated committee members.

Please note if you opt out of Mailchimp you will not receive advance information about film screenings and other activities.

Access to your information and correction

We want to make sure that your personal information is accurate and up to date. Accordingly, you are entitled to view, amend or delete personal information that we hold about you.

We will keep your personal data for as long as you use our services. If you haven't used our services for over a year or programme season (whichever is longer), we will delete your postal address from our mailing list. You can unsubscribe from our email list (Mailchimp) at any time.
